



Non-Refundable Reservation Agreement

This Reservation Agreement between the person or entity identified below as you and Mammoth Overland, located at 19825 141st PL NE, Woodinville, WA 98072, U.S.A., is for your reservation of a Mammoth Overland Trailer delivered at an out of state show referenced in the listing.

1. Reservation

By entering into this Reservation Agreement, you hereby confirm that you wish to reserve a Mammoth Overland Trailer and take delivery at the show described in the reservation listing.

2. Nature of Agreement; Binding Reservation Payment

This Reservation Payment is NON REFUNDABLE. This Agreement does not constitute an agreement for the sale of a trailer. When we notify you of the beginning production of the trailer and you wish to proceed with the purchase, such sale and purchase will be governed by a separate and legally binding Purchase Agreement between you and Mammoth Overland. In the event a purchase is made, your Reservation Payment will be credited against the purchase price. All prices mentioned herein are in U.S. Dollars. By signing this reservation, the Customer acknowledges that submission of the reservation payment constitutes a binding agreement to reserve a specific trailer for delivery at a designated show. The reservation payment is nonrefundable and secures the Customer's priority for the selected unit.

Customer further understands and agrees that, prior to delivery, the trailer may be utilized by the Company's team for transport purposes, including temporary occupancy en route to the show. Upon arrival, the trailer will be presented as a display model during the event. As such, the Customer consents to reasonable public access, including entry by prospective buyers and attendees for viewing and demonstration purposes.

3. Effective Date; Reservation Process

This Agreement is formed and becomes effective when we receive both this signed Agreement and your Reservation Payment in the amount of **(\$5000) for HV**. Once you have reviewed and completed this document, you may execute this Agreement via the U.S mail and/or by scanning and emailing it to whomever sent it to you. You may make your Reservation Payment by check made out to Mammoth Overland or by wire transfer as stated below. Once this Agreement becomes effective, you will be placed on the reservations list and will receive communications about our progress for the trailer to be delivered to the designated show.

4. Order Process

When the start of production of your reservation nears, we will send you a Mammoth Overland Order Form asking you to confirm your options package (wrap application, accessories, etc.) and to provide full details regarding the purchaser of the trailer.

Mammoth Overland will create an order for your trailer containing the information provided by you, and a Purchase Agreement indicating the current purchase price of your trailer, full details of your trailer, warranties, addendums, etc. Mammoth Overland will then submit this legally binding Purchase Agreement to you for your review.

If you wish to proceed and purchase the trailer, you must sign and return the Purchase Agreement to Mammoth Overland, at your earliest convenience.

5. Payment Schedule

HV -\$5,000, Non-refundable deposit due with the return of this Reservation Agreement to place your reservation on our reservation list and reserve the transportation of your trailer to the designated show

The Final Payment, or financing, will be due prior to your trailer leaving the Mammoth Overland facility, in Woodinville, WA.

5. Cancellations

If the cancellation of your Mammoth Overland Trailer is received in writing after sending in your Non-refundable deposit, & before submitting your signed Purchase Agreement, your \$5000 deposit will not be refunded in full.

YOU UNDERSTAND THAT MAMMOTH OVERLAND WILL NOT HAVE BEGUN MANUFACTURING THE HV TRAILER AT THE TIME OF YOUR RESERVATION.
